Ten Signs of Job Dissatisfaction – Don't Ignore Them!

The New Year is a great time to analyze your job satisfaction. As you make your new year's resolutions, include career fulfillment as a top priority.

There are ten sure signs that you are experiencing job dissatisfaction. If you:

Dread Mondays or coming to work
Can't wait for Friday
Are often bored at work
Feel tired or chronically fatigued
Avoid your boss and dread meetings
Have no enthusiasm or sense of self worth
Feel like you are getting nowhere in your job
Take work stress home
Question your choice of industry or occupation
Can't think of a way out

Think Spring!

Don't Let Jack Frost Wreak Havoc on Your Viscosity Levels

Special Precautions Must Be Taken During the Winter Months to Avoid High Viscosity in Storage

It may be lovely weather for a sleigh ride, but the winter wonderland that is fast approaching can really wreak havoc on the viscosity of the adhesive you keep in storage.

The viscosity of an adhesive varies proportionally with the temperature of the adhesive. If storage tanks are allowed to cool down over the course of a chilly weekend, the viscosity will increase, resulting in a very thick paste.

"The adhesive should be kept at 100 degrees Fahrenheit in storage. If you walk into the plant on a Monday morning and find that the temperature of the adhesive has dropped down to 80 degrees, it takes a long time to heat it back up," said Gus Fischer, technical service manager for Corn Products US, a business unit of Corn Products International, Inc.

The inverse relationship of viscosity to temperature is approximately 10 percent for every two degrees Fahrenheit change.

To properly control the temperature of the adhesive you keep in storage, a Temperature Viscosity Control System (TVC) is required. Typically, this system uses a small tank of heated water positioned slightly above and between the adhesive storage tanks. Water from this tank is circulated through coils inside the storage tanks at the same time that agitators are moving the adhesive.

"At this time of year, the water temperature should be heated at a temperature that is 10 degrees Fahrenheit below the lowest gel temperature," said Al Bromberek, customer support manager for Corn

Products. "If the gel temperature is 142 degrees Fahrenheit, you'll want to run the TVC water at 132 degrees Fahrenheit. The higher you can run the water temperature without gelatinizing the adhesive, the more efficient the TVC system will become. The longer it takes for the temperature to rise, the longer the storage tank agitators must run. This increases the risk of shear." Be careful, though, to make sure that the TVC water doesn't become too hot. If the TVC water temperature is too high, gelling of the adhesive may occur on the coil inside the tanks. The gelled starch can act as an insulator, greatly decreasing the efficiency of the TVC system."

Adhesive should be kept at 100 degrees Fahrenheit in storage. In order to ensure that this temperature is maintained during the winter months, corrugating plants should have their TVC systems checks to make sure that they are in good operating condition.

"We generally recommend that customers check their TVC systems in the fall, before temperatures drop and viscosity becomes an issue," Fischer said. "A lot of time, our technical service representatives can check a customer's TVC system during the fall, and will point out any potential problems to the customer. This allows the customer to make any necessary adjustments before winter."

Plants that have complete steam shutdown on weekends rely on electric units to heat TVC water. This is an important consideration on new installations to ensure proper viscosity control.

Customers also may adjust for high viscosity by carefully monitoring their glue roll settings. "If you close down the glue roll setting when the viscosity is too high, you'll be able to put less starch on the glue line," Fischer said. "As the adhesive warms up and the viscosity levels drop, you'll need to adjust the settings again to account for this."
