



## Corrugated Packaging Council Election Process

There are currently 2 positions on the Corrugated Packaging Council (CPC) which will become vacant in November of 2018. If you would like to run for one of these positions, please fill out the attached application form.

### REQUIREMENTS:

It is a three year term (beginning November 1, 2018 and ending October 31, 2021). Applicants must be a member of TAPPI in good standing and employed by a manufacturer or supplier to the corrugated or converting industry. Members are required to attend two face to face meetings each year – one in the early spring and one in the fall after the annual conference. CPC members are also expected to support the corrugated division with their attendance at all annual conferences for the division.

- Candidate data sheets submitted to Kristi Ledbetter at TAPPI by **Aug 3, 2018**
- Official ballot sent out for electronic vote by **August 10, 2018**
- Election closes **September 14, 2018**
- Results officially announced at **2018 TAPPI/AICC Corrugated Week, September 24-27, Indiana Convention Center, Indianapolis, IN**
